TERMS AND CONDITIONS OF SALE

This document was written in "Plain English". The words CUSTOMER, YOU and YOUR refer to the customer. The words SELLER, WE, the COMPANY, US and OUR, refer to the Pure & Secure, LLC. Every attempt has been made to eliminate confusing language and create a simple, easy-to-read document.

BRAND NAME: Dental Purity™ is a copyrighted brand of Pure & Secure, LLC.

ACCEPTANCE: All orders are subject to acceptance by Pure & Secure, LLC. in Lincoln, NE.

PRICES: The prices listed are subject to changes, anytime, at the discretion of the Company. All prices and shipments are F.O.B. the Company in Lincoln, NE, unless specifically indicated otherwise.

TAXES: Prices do not include City, County, State, or Federal taxes. All applicable taxes shall be paid by the customer.

PAYMENT TERMS: All purchases are on a pre-pay basis unless other terms have been agreed to in writing.

SHIPPING TERMS: Shipping and handling fees are due before shipment. All shipments are EXW Lincoln, NE, unless specifically indicated otherwise. The Company will choose the shipping method and the carrier unless other shipping methods are requested.

SHIPPING DATES: Shipping dates are estimated contingent upon receipt of a pre-paid order. The Company assumes no responsibility or liability for delays in shipment.

RETURNS: Written permission must be obtained from the Company before merchandise may be returned for exchange or refund. Customer must contact the Company to obtain an authorization number and return the Material to the location designated by the Company. Any Material returned to the Company without proper authorization will be returned to Customer at Customer expense. All transportation charges for returned merchandise must be PREPAID by the shipper. All returns must be made in the original packaging. The Company will only accept returns on undamaged equipment. Returned saleable merchandise accepted by the Company for credit is subject to a **20% restocking charge**. No returns after 30 days from original shipment date.

WATER QUALITY: Dental Purity™ products produce purified water through the process of steam-distillation. This process boils tap water, produces steam and then separates the steam and cools it back down into high-purity water, which is then stored in a food-grade storage container. If the machine is operating in normal operating parameters the purified water should have less than 10 ppm of total dissolved solids (TDS), and will typically have less than 5 ppm. Maintenance of the machine and proper operation can affect performance over time. During the distillation process the water becomes sterilized because of the prolonged boiling process. No claims are made however, that the distilled water will remain sterilized.

CLAIMS: Claims for merchandise lost or damaged during transit must be made against the carrier by the Customer. Claims will not be considered unless they are submitted in writing within ten (10) days after receipt of the merchandise. Such claims should be submitted to Pure & Secure, LLC., NW 44th Street, Lincoln, NE 68524.

FACTORY WARRANTY: The manufacturer of the equipment offers a comprehensive warranty that covers the materials and workmanship of the appliance. The factory warranty does not include labor, shipping or service charges. A copy of the Original Warranty Statement is available upon request by the Customer. No representative is authorized to assume for the Company any other liability in connection with the Company's products.

LEASING: The Company may be able to offer the Customer the option to lease their purchase through a 3rd party leasing company. Third-party leasing will require additional paperwork and credit approval. Third-party leasing companies will have their own requirements and terms and conditions that are separate from this agreement. Seller is not responsible for the performance of any third-party leasing companies.

DEFAULT: The Customer authorizes the Company to charge the Customer's credit card and /or bank account for any default or indebtedness to the Company due to failure to pay.

CANCELLATION OR CHANGES IN ORDERS: Cancellation of or changes to orders by the Customer are accepted only upon terms that protect the Company against loss.

DISCLAIMER OF LIABILITY: The Company will not be liable for injuries or damages to persons or property resulting from any cause whatsoever, with the exception of bodily injuries, death or tangible property damage caused by the willful misconduct or gross negligence of the Company. This limitation applies to all material and services performed during and after the warranty period. In no event shall the Company be liable for any damages resulting from loss of revenue or profit and the Company further disclaims any and all liability for indirect, incidental, special, consequential, or other similar damages. If any remedy hereunder fails of its essential purpose, or in any other event, the Company's aggregate liability hereunder shall not exceed the depreciated value of the affected material or the actual amount paid to the Company for products and/or services.

LEGAL VENUE: This Agreement shall be construed, interpreted and applied in accordance with the laws of the State of Nebraska. Any action to enforce or construe this Agreement shall be brought only in the courts located in Lincoln, Nebraska, U.S.A. as the exclusive venue.
